## **Date of the General Assembly**

The Board of the APEEE of Brussels IV wishes to inform you that our annual General Assembly (GA) will take place on **Thursday 8<sup>th</sup> December 2016 from 8:00 pm to 11:00 pm**, in the Charlemagne Building, 170 rue de la Loi 1040 Brussels. We will be able to confirm if interpretation will be provided closer to the meeting date.

## **Proxy**

Class representatives who are unable to attend the GA are encouraged to arrange their proxy using either the form attached with this mail, alternatively by downloading it from <u>our APEEE website</u>. A proxy on smartphone (not printed) will not be accepted.

## Language Section Meetings prior to General Assembly

On the evening of the GA, dedicated spaces will be available prior to the GA meeting <u>from 7:00 pm to</u> <u>8:00 pm</u> so that all language sections can hold discussions. You have the opportunity here to select your section representative if not already selected, define how the communication will be held within your section and with other linguistic sections, and also to focus your thoughts ready for the GA.

## **Pre-registration**

The announcement of the GA will be sent out by 24<sup>th</sup> November 2016 at the latest, and this will include a web-link for pre-registration.

As done last year, we highly recommend that all attendees pre-register in order to facilitate access to the European Commission Building. Officials and other agents are welcome to register as well. We will have a better view on how many may attend, and consequently the size of the dedicated areas needed for the individual language section meetings.
