1. Adoption of agenda

The agenda was adopted.

2. Responsibilities of the Director Authorisation for payments

Referring to some inconvenient constraints on signature delegation and limits on payment amounts with the bank (for e.g. when paying transport company bills or salaries) Eric set out some possible ways to circumvent these problems. The bank proposed to have 2 signatures (the President and the Treasurer) and 2 delegated signatures.

The question is:
