OUORUM

We would like to draw your attention to the fact that:

The Extraordinary General Assembly (EGA) to amend the APEEE Statutes of the APEEE of Brussels IV will have two parts:

- 1) vote to add an aim of the Association, requiring 4/5 majority of the full, present or represented members (Class Representatives who have paid the APEEE membership fee 2018-2019).
- 2) vote on the entire draft text, requiring 2/3 of the full, present or represented members (Class Representatives who have paid the APEEE membership fee 2018-2019).

The Ordinary General Assembly may validly deliberate if at least 1/10 of the full members (Class representatives who have paid the APEEE membership fee 2018-2019) are present or represented.

REGISTRATION

Starts at 6:30 pm. Please be on time! Sandwiches from the APEEE cafeteria will be on offer, but it is first come, first served. Upon arrival at the Charlemagne Building, you will be able to pick up a badge at the registration desk before the security check.

PROXY (for Class Representatives who cannot attend the EGA/OGA)

According to the article 8.3 of the Statutes, if a Class Representative (Full member) cannot attend in person, he/she can be represented by another Class Representative (Full member) by means of a Proxy.

In order to reach the required quorum for the OGA (1/10) and EGA (2/3 and 4/5), we require the Full members who cannot attend to complete and sign the <u>Proxy form</u>. A full member cannot represent more than three effective members.

<u>The proxy form manually signed (original or hard copy)</u> should be provided by the delegated Full member at the time of registration before the start of the EGA. A proxy on smartphone (not printed) will not be accepted.

VOTING PROCEDURE

According to article 8.2 of the Statutes, only full members can vote as long as the membership fee for 2018/2019 has been paid. If you have made your payment recently, please bring the proof of payment at the Assembly to speed up your registration.

As previous years, an electronic voting system will be in place to count the votes and your registration will help us ensure that the required number of voting system devices will be available.

INTERVENTION during the EGA/OGA

We would like to remind you that all Parents attending the General Assembly can request to the Moderator to take the floor, to express their views and give an advisory opinion. All participants are kindly requested to respect the timing given for the intervention and the Moderator reserves the right to make sure the planning of the intervention is respected to allow a constructive discussion.

POWERS OF THE GENERAL ASSEMBLY

The following subjects are the sole responsibility of the General Assembly:

- a) the election and revocation of the members of the Board;
- b) the approval of the annual accounts and of the annual budget;
- c) the discharge of their management to the Board and to contingent Auditors;
- d) determine the general direction of strategy and policy of the Association

ADMINISTRATIVE BOARD - APPLICATION TO VOLUNTEER AS BOARD MEMBER

Each Parent of the European School of Brussels IV having paid the APEEE membership fee 2018/2019 can stand as candidate to join the Administrative Board for a mandate of two years.
