Proxy

Pre-registration

The announcement of the GA will be sent out by 18th November 2019 at the latest, and this will include a web-link for pre-registration.

As done last year, we highly recommend that all attendees pre-register in order to facilitate access to the European Commission Building.

Officials and other agents are welcome to register as well. We will have a better view on how many attend.

This formality is not a requirement but we encourage you to pre-register to aid us with our logistical preparation. All information collected will be treated accordingly with EU data protection policy, and will be deleted on 3rd December 2019.
