PRE-REGISTRATION

You are kindly requested to PRE-register in advance, even if you are an official of a European Institution, using the registration link below:

Your registration will help to understand how many Parents and Class Representatives will be attending to better organise the Assembly.

QUORUM

We would like to draw your attention to the fact that the Ordinary General Assembly may validly deliberate **if at least 1/10 of the voting members** (Class representatives who have paid the APEEE membership fee 2019-2020) are present or represented.

REGISTRATION

Starts at 18h30. Please be on time! Sandwiches from the APEEE cafeteria will be on offer, but it is first come, first served. Upon arrival at the Albert Borschette Congress Center, you will be able to pick up a badge at the registration desk before the security check. Please take note that your personal data will be deleted on 3rd December 2019.

PROXY (for Class representatives who cannot attend the OGA)

According to the article 9.16 of the Statutes, if a Class representative (voting member) cannot attend in person, he/she can be represented by another Class Representative (voting member) by means of a Proxy.

In order to reach the required quorum for the OGA (1/10), we require the Voting members who cannot attend to complete and sign the [Proxy form](#). A voting member cannot represent more than three voting members.

The proxy form manually signed (original or hard copy) should be provided by the delegated class representative at the time of registration before the start of the OGA. A proxy on smartphone (not printed) will not be accepted.

VOTING PROCEDURE

According to article 9.15 of the Statutes, only class representatives being full members (hereafter called voting members) can vote as long as the membership fee for 2019/2020 has been paid. If you have made your payment recently, please bring the proof of payment at the Assembly to speed up your registration.

As previous years, an electronic voting system will be in place to count the votes and your registration will help us ensure that the required number of voting system devices will be available.

INTERVENTION during the OGA

We would like to remind you that all Parents attending the General Assembly can request to the Moderator to take the floor, to express their views and give an advisory opinion. All participants are kindly requested to respect the timing given for the intervention and the Moderator reserves the right to make sure the planning of the intervention is respected to allow a constructive discussion.

POWERS OF THE GENERAL ASSEMBLY

The following subjects are the sole responsibility of the General Assembly:

- the election and revocation of the members of the Board ;
- the approval of the annual accounts and of the annual budget;
- the discharge of their management to the Board and to contingent Auditors;
- to determine the general direction of strategy and policy of the Association

ADMINISTRATIVE BOARD-APPLICATION TO VOLUNTEER AS BOARD MEMBER

Each Parent of the European School of Brussels IV having paid the APEEE membership fee 2019/2020 can stand as candidate to join the Administrative Board for a mandate of two years.

This role is on a voluntary basis and the APEEE IV needs motivated Parents to guarantee the smooth running of the Association for the well-being of our children. Your active help is essential to achieve the pedagogical objectives and services for the benefit of the School Community.

You will have the opportunity to be truly involved in School life. You will be attending monthly meetings of the Board of the APEEE and your support will be needed on various topics such as pedagogy, communication, working groups, services. In accordance with articles 10.5 and 10.7 of the Statutes, the administrators (within the Board) are maximum 21, with at least two representatives from each linguistic section.
