FOCUS ON REDUCING THE COSTS

- Since March 16th school closed
- No services provided by APEEE
- Focus on reducing costs while still keeping capability to reopen.

Vote on Reimburssement - Option 1

We are an AISBL ("association internationale sans but lucratif") and our objective is not to make a profit each year. We have therefore, through General Assembly decisions, accepted loss-making budgets for specific years. We should continue in this vein and reimburse the payers (paying parents and/or PMO) in order not to make any profit out of our transport, food and périscolaire activities, meaning we keep the funds needed to cover our fixed costs (donations are not included in fixed costs), the rest being reimbursed to the payers – parents and/or PMO.

Vote on Reimburssement - Option 2

We are - partly - running services in many respects like a company and we deliver services to our clients. We should therefore reimburse the payers (parents and/or PMO) the amount corresponding to the days our services were not available. We have a reserve constituted over the years to cover the APEEE's liabilities, including to staff, which we could take from in order to fully reimburse the payers (parents and/or PMO), including fixed costs.
