Motion on SOMERFESTO to be presented to the parents during the General Assembly 2026

Somerfesto is a community party, organized by an organizing committee with the help of the parents who donate money, products and time. It aims to bring the school community closer and to collect money to support the community via the Community and Social funds.

The organizing committee was composed in the last years of five persons. As you can imagine, in order to organize such a party, five persons are not sufficient, therefore we needed help from the paid staff of the APEEE.

Until now, this help was organised as follows:

- if the staff helped during working hours, it was considered a task falling in the job description and counted towards the normal time of work;
- during Somerfesto, the periscolaire monitors, who are contractors and not staff, who supervised the attractions, were paid (for one day) separately from the Somerfesto account. The other staff members that were working on a voluntary basis outside normal working time were given free time equal to the number of hours that they helped for Somerfesto.

During the last year, several members of the Board supported the request of the APEEE Director that staff members that were working extra time to benefit of extra pay when volunteering for Somerfesto activities.

Since this is an event that aims to gather funds in order to support different school projects, the organisation and the way in which Somerfesto functioned, both towards the organisers and towards the staff, was to maximise the amount raised to support the Community.

In this regard, for example, the members of the organizing committee invest hundreds of hours in the organisation of this community event, but do not have any privileges, neither them nor their families, in terms of access to this event.

Against this background, we ask this Assembly to decide how staff members volunteering to work for Somerfesto and doing extra hours should be recompensated.

Question: How should the staff members volunteering to work for Somerfesto and doing extra hours should be recompensated for the extra time spent with this event's organisation?

- A. They should be recompensated with free time, as until now.
- B. They should be paid by the respective APEEE service to which they belong for the extra time.
- C. They should be paid from the Somerfesto account for the extra time.
